INSTRUCTIONS & GUIDELINES FOR NRI CANDIDATES

II. **DEFINITIONS**:

NRI Candidate: A candidate may be considered for the admission under NRI quota, provided his either of the parents (i.e. father or mother), Parents of Father/Mother, Brother/Sister of the parents or the candidate's own Brother/Sister has the NRI status as per rules. The candidate must submit a certificate from Foreign-situated Indian Diplomatic Mission/Embassy/Chancellery/ Commission.

III. BASIC ELIGIBILITY CRITERIA:

The candidates shall be considered for admission to First Year B.E. course (4YDC) against NRI seats who have passed the qualifying examination i.e. Class 12th of 10+2 System or equivalent examination with Physics, Chemistry & Mathematics subjects.

- IV. The application in prescribed proforma must be sent to the Institute alongwith:
 - (A) Photocopies of Mark sheets of 12th & 10th classes of 10+2 system of Board of Secondary Education Madhya Pradesh or equivalent examination.
 - (B) A Certificate from Foreign-situated Indian Diplomatic Mission/Chancellery/ Embassy to the effect that the Father/Mother of the candidate is Non-Resident Indian in that Country.
- V. The completed application in prescribed proforma must reach the Office of the Director, Shri G S Institute of Technology & Science, Indore, 23, Park Road, Indore on or before 5:00 PM on 16/07/2010
- VI. The admission will be made on merit basis for which the counselling will be held same on 18/07/2010 at 10:00 A.M. in the Office of the Director in the Institute.
- VII. The candidate shall be required to report to the Institute along with his/her Father or Mother to the Institute to complete the formalities of Admission and Registration on the date specified i.e. on 18/07/2010. If father and mother both are not alive, then the signature of the Guardian shall be allowed and admitted on the declarations, provided proper certificate of Guardianship is produced.
- VIII. The candidates shall be required to deposit the Annual Fee of US \$ 3000 every year plus Caution Money of US \$ 1500 (Payable once & refundable after completion of degree course) plus all other fees and guarantees as per rules as a pre-requisite for admission. The Candidate is therefore required to bring certified Bank-References for paying capacity. However, on withdrawal or cancellation of admission, 10% of the total fees deposited (excluding caution money) will be deducted at the time of refund.
- IX. The provision of Transfer from one Institute to other Institute in M.P. shall not be applicable.
- X. The hostel-accommodation shall be available as per Institute rules applicable in such cases.
- XI. All original documents and their certified photocopies must be attached as per LIST -1.
- XII. The candidate is required to bring appropriate certificate of annual income of Father/Mother/Guardian.
- XIII. The candidate must submit School/College Leaving Certificate (Transfer Certificate) in original at the time of admission or within seven days of his admission.
- XIV. The candidate must attend all the classes regularly. If he is continuously absent from the classes for more than fifteen days, the admission may be cancelled.
- XV. For any dispute in connection with your admission, the interpretation given by the Director of the Institute shall be final. The jurisdiction of the Court of Law at Indore shall be binding for judicial review in all matters related to it or arising out of it.

Provisional admissions shall be given strictly as per the prevailing rules prescribed by Govt. of M.P. for NRI candidates and subject to approval from AICTE.
